



2000 Legislation Explicitly Affecting Administrative Rules

During the 2000 General Session, the 53rd Legislature passed 393 bills. Of those bills, an estimated 67 bills contain explicit language requiring or permitting rulemaking. The Division of Administrative Rules has prepared the following list of bills to facilitate state agency compliance with legal rulewriting requirements. This list should not be considered exhaustive or conclusive. This list does not include bills that contain implicit rulemaking requirements. Each agency is responsible for reviewing legislation and determining provisions that—explicitly or implicitly—require rulemaking. Consider this list a "heads-up."
